

1 = Source, 2 = Drain, 3 = Gate 2, 4 = Gate 1




Figure 7. Transducer Gain vs. Gate 1 Source Voltage




Figure 8. Forward Transadmittance vs. Drain Current




Figure 9. Short Circuit Input Admittance




Figure 10. Short Circuit Forward Transfer Admittance




Figure 11. Short Circuit Output Admittance




Figure 12. Input reflection coefficient




Figure 14. Reverse transmission coefficient




Figure 13. Forward transmission coefficient










Figure 15. Output reflection coefficient


