




Figure 1. Static Characteristic




Figure 2. DC current Gain




Figure 3. Base-Emitter Saturation Voltage
Collector-Emitter Saturation Voltage




Figure 4. Switching Time




Figure 5. Safe Operating Area




Figure 6. Reverse Bias Safe Operating Area




Figure 7. Derating Curve of Safe Operating Area





Figure 8. Power Derating
