






Fig.1 Relative Intensity vs. Wavelength




Fig.2 Forward Current vs.
Forward Voltage




Fig.3 Forward Current
Derating Curve




Fig.4 Relative Luminous Intensity vs. Forward Current




Fig.5 Luminous Intensity vs.
Ambient Temperature




Fig.6 Spatial Distribution
