




Fig. 1 Test Circuit

Fig. 2 Test Circuit of Ripple Rejection






Fig. 4 Power Dissipation vs. Ambient Temperature(PQ15RW11/21)



Note) Oblique line portion: Overheat protection may operate in this area.








Fig. 6 Overcurrent Protection Characteristics (Typical Value) (PQ15RW11)
