



Transmissive Optical Sensor with Phototransistor Output


Description

These devices have a compact construction where the emitting-light sources and the detectors are located face-to-face on the same optical axis. The operating wavelength is 950 nm.

The detector consists of a phototransistor. Due to the special construction, the depth of the gap is equal to a package height of 4 mm.


Applications

- Position sensor for shaft encoder,
- Detection of opaque material such as paper, IBM cards, magnetic tapes etc.,
- Limit switch for mechanical motions in VCR,
- General purpose wherever the space is limited




Figure 1. Test circuit




Figure 2. Mechanical setup




Figure 3. Switching times




Figure 4. Total Power Dissipation vs.
Ambient Temperature




Figure 7. Collector Dark Current vs. Ambient Temperature




Figure 5. Forward Current vs. Forward Voltage




Figure 8. Collector Current vs. Forward Current




Figure 6. Relative Current Transfer Ratio vs.

Ambient Temperature




Figure 9. Collector Current vs. Collector Emitter Voltage






Figure 10. Current Transfer Ratio vs. Forward Current




Figure 12. Relative Collector Current vs. Displacement





Figure 11. Turn on / off Time vs. Collector Current
