Description


These new devices have been designed to meet the increasing demand for surface mounting technology. This device is used for outdoor or for low power applications.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature




Figure 3. Forward Current vs. Pulse Length




Figure 4. Rel. Luminous Intensity vs. Angular Displacement






Figure 5. Forward Current vs. Forward Voltage




Figure 6. Rel. Luminous Intensity vs. Ambient Temperature




Figure 7. Rel. Lumin. Intensity vs. Forw. Current/Duty Cycle




Figure 8. Relative Luminous Intensity vs. Forward Current






Figure 9. Relative Luminous Intensity vs. Wavelength
