




TSDF1205 Marking: F05 Plastic case (SOT 143)


1 = Collector, 2 = Emitter, 3 = Base, 4 = Emitter







TSDF1205R Marking: 05F Plastic case (SOT 143R)




Figure 1. Total Power Dissipation vs. Ambient Temperature




Figure 2. Transition Frequency vs. Collector Current




Figure 3. Collector Base Capacitance vs. Collector Base Voltage






Figure 4. Noise Figure vs. Collector Current


Dimensions of TSDF1205 in mm



Dimensions of TSDF1205R in mm










Dimensions of TSDF1205W in mm

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
