The Z86230 simplifies design efforts as a onechip solution to decode and recognize which shows will be blocked. Coupling with a standalone line 21 decoder such as Z86129 for Extended Data Service (XDS), the Z86230 supports two different I<sup>2</sup>C addresses, enhancing its ability to select and direct incoming data.



It features a full matrix table preprogrammed to support the blocking of age- and content-based program ratings and four existing North American Content Advisory Program Ratings systems, including:


